MAJOR ZINC-SKARN DISTRICT IDENTIFIED AT UBEONG PROJECT IN SOUTH KOREA

- Accelerated and targeted work programme identifies major zinc-skarn district centred on the extensive Chilbo Mine historical workings at the Ubeong Zinc-Silver Project in South Korea
- New, high-grade zinc-silver (+/- lead, copper) results include 2m @ 29% Zn from outcropping massive-sulphide lodes associated with workings now located over a 2km x 2km area
- An initial geophysical survey completed in the Chilbo historical workings area has identified significant mineralised structures and "bullseye" magnetic anomalies associated with intense skarn alteration and sulphide mineralisation
- Detailed mapping and soil sampling programmes, currently in progress, will assist definition of drilling targets for high-grade zinc-skarn mineralisation, planned to be tested in 2017




Figure 1: Ubeong Projects, skarn-limestone unit & tenements on Aeromagnetic image^{D3, D4}

Peninsula Mines Limited ("Peninsula" or the "Company") is very pleased to announce that further high-grade zinc-silver (+/- lead, copper, gold) channel sampling results, together with detailed ground geophysics and the commencement of mapping and soil sampling programmes, have identified a major mineralised zinc-skarn district associated with the historical Chilbo Mine workings at the Company's Ubeong Zinc-Silver Project in South Korea (see Figure 1).

The newly sampled workings are located to the south of previously identified mineralisation (up to 39.7% Zn^{D2}, and have produced **high-grade channel sampling results of up to 2m @ 29% Zinc (Zn)** from substantial stopes and adits on outcropping lodes, as summarised in Table 1 below:

High-grade sulphide mineralisation and historical workings at the historical Chilbo Mine are interpreted to be associated with extensional fault-structures that intersect the main, skarn-altered and magnetised limestone unit. Regional magnetic trends and mapping indicates that this faulting has resulted in a major offset and re-orientation of the skarn-limestone unit from east-west trending to northeast-southwest trending (see Figure 1). However, the regional aero-magnetics and geological mapping D3,D4 information is too coarse to determine detailed drilling targets associated with these mineralised structures, and so the Company initiated a detailed ground magnetics survey and mapping programme over the site of the historical Chilbo Mine workings.

The detailed ground magnetic survey was initiated in early November 2016 and, despite the challenging and steep terrain (see Figure 3), has already covered a 1.5km x 1.5km area on 50m to 100m line spacing, over the main initial target area associated with the Chilbo Mine workings. The survey was initiated by Southern Geoscience Consultants (SGC) of Perth, and continued by the Company's personnel, and also included an initial electromagnetics (EM) trial, the results of which are being assessed.




Figure 2: Ubeong Project, Chilbo Mine-workings area, TMI image of ground magnetics, skarn-limestone unit (pattern) and structure (blue lines) interpretation, with workings (yellow) and results to date (squares)

The initial results of the ground-magnetics survey are shown on Figure 2 with an interpretation by the Company that has highlighted several strongly magnetic zones associated with magnetite bearing skarn alteration in the limestone unit. In addition, distinct offsets and magnetic disruptions are evident, in many cases associated with mapped workings and high-grade zinc-silver rock-chip results.

Detailed mapping conducted by experienced (in South Korea) consultant geologist, Malcolm Forbes (FAusIMM), is currently in progress, and has resulted in the identification of numerous additional workings (see Figure 2), many of which have yet to be sampled. The extent of the workings and the association of the highgrade identified mineralisation within the main skarnaltered limestone unit, has led to the conclusion that the Company has identified a major zinc-skarn district, with the Chilbo historical mine on the eastern end of the system, whilst 10km to the west is the operating Kumho Zinc Mine (Figure 1), just outside the Company's tenement applications.

In order to define the extent of mineralisation, a soil sampling programme will be conducted along the 100m spaced magnetics lines with the objective of defining anomalies associated with the mineralised trends.

Once the mapping and soil sampling work is completed, drilling targets for high-grade massive sulphide mineralisation may be defined, for possible testing early next field season (2017), subject to grant of the key tenements targeted and access permission to the relevant drill-sites from the Korean Forestry Service.

Background to the Ubeong Zinc-Silver Project:

Peninsula has secured tenement applications over the eastern 10 km of strike length of a highly prospective limestone-skarn unit, that includes the historical Chilbo Zinc Mine and adjoins the operating Kumho Zinc Mine (see Figure 1).

The high-grade zinc-silver mineralisation associated with the historical Chilbo Mine occurs towards the eastern end of the skarn-unit, associated with a mineralised northwest trending fault zone that has offset the limestone.

The Company has previously announced high-grade zinc-silver (+/- lead, copper, gold) results, produced from historical dumps and adits in the Chilbo historical mine area^{D1, D2}. The Company has also commenced a ground-magnetic survey that will map the magnetic skarn-unit trend and allow the Company to target fault zones likely to be associated with zinc-silver mineralisation.

Detailed mapping and grid soil sampling has commenced with the objective of defining areas of surface anomalism along the 10km strike of the limestone skarn-unit.

The objective of both the geophysical programme and the soil sampling is to define drilling targets for massive-sulphide zinc-silver mineralisation.

The Company will consider making application for funding support from the Korean government agency, KORES. Any application to KORES will be subject to prior approval by the Ministry of the application for Exploration Licenses filed in October this year.

Meanwhile, the Company will look at preparing Korean Forestry Service submissions for approval of drill access tracks and the establishment of drilling pads, for drilling to test targets in the Chilbo historical mine workings area during 2017 (Figure 3).

The Ministry of Trade, Industry and Energy (MOTIE) reviews the MDS and if satisfied, will issue an exploration right.

The Company has been granted tenure for 6 months and is required to submit an MDS report for each of the 21 applied tenements prior to the end of the 6 month application period. Following the successful filing of the MDS, the applicant is required to file a Prospecting Application (PA). The PA report details the planned exploration activities to be completed over the tenement during the 3 year prospecting period. Typical calc-silicate skarn alteration minerals such as hedenbergite and epidote were observed in rock chip samples. The intense magnetite and pyrrhotite mineralisation is typical of many other Korean skarn deposits. The intense magnetic high sympathetically tracking the mapped limestone unit is interpreted to reflect strong magnetite and pyrrhotite mineralisation associated with skarnification of the limestone.
		The Kumho mine to the west of the Ubeong Project was discovered during the Japanese occupation of Korea and initially mined as a manganese bearing skarn deposit. Subsequently, copper, lead, zinc, silver and gold mineralisation was discovered at depth in the 1940s. The Kumho mine has operated intermittently since 1930s with mining activities ceasing at times due to declining metal prices. The mine is currently active and is reportedly operating at around a 6% zinc head grade.
