Issue of Shares - Section 708A Corporations Act Cleansing Notice

Vimy Resources Limited ("Company" ASX: VMY) has today issued 532,072 fully paid ordinary shares in the Company to a sophisticated and professional investor, in lieu of a quarterly cash interest expense payment due under an unsecured bridging loan.
