Placement Completed

Eclipse Metals Limited (**Eclipse** or **the Company**) (ASX: EPM) is pleased to announce the successful completion of a private placement (**Placement**) to new investors in collaboration with an Eastern States independent equities provider.

Eclipse has raised a total \$360,000 (before costs). A total of 60,000,000 fully paid Ordinary Shares in the capital of the Company have been issued to new investors at an issue price of \$0.006.

Funds raised from the Placement will enable the Company to conduct further exploration work and provide working capital for the evaluation of new opportunities.

The Eclipse Board is pleased with the new and strong support for this raising which reflects the Company's unique position of having assets prospective for uranium, gold, manganese and base metals. This additional capital provides the Company with the flexibility to quickly progress further exploration work.

Geophysical Surveys

The initial phase of gravity and passive seismic geophysical surveys conducted during November and December 2016, on three (3) old manganese mining areas in the Mary Valley project, has been completed.

The project area has shown potential for extension of known mineralisation and further confirmatory surveys are presently in progress. Final results for all surveys are expected to be available soon after collation and interpretation of the data generated by these surveys.
