
NOTIFICATION UNDER SECTION 708A(5)(E)

On 30 January 2017 Canyon Resources Limited ("CAY" or "the Company") issued 13,177,178 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 30 January 2017.
