Appointment of Tim Brewer and change of company secretary

PERTH, 6 FEBRUARY 2017: Cre8tek Limited ("Cre8tek" or "the Company") (ASX: CR8) is pleased to announce the appointment of Tim Brewer as an advisor to Flamingo Customer Experience Inc.

Tim is an innovation and start-up advocate, professional director and advisor who works with entrepreneurs and companies around the world to formulate, launch and maintain strategies aimed at supporting growth and ultra scalability in software as a service (SaaS) companies.
