## Suspension

The Directors of migme Limited (MIG or the Company) request a Suspension in the Company's securities.

As required by Listing Rule 17.2, MIG provides the following information:

- the Suspension is requested pending the finalisation of the Company's US\$6 million Convertible Note financing (first announced on 9 December 2016) and the release of an announcement concerning that Convertible Note financing;
- the Company expects the Suspension to end on or prior to the commencement of trading on Wednesday 15 February 2017;
- it is expected that the release of an announcement concerning the Convertible Note financing will result in the end of the Suspension;
- MIG is not aware of any reason why the Suspension should not be granted; and
- The Company is currently negotiating with a number of financiers and corporate entities in relation to the finalisation of the Convertible Note series. Those negotiations have been extended to include a variety of other financial, corporate, structural and strategic options across a number of jurisdictions. Given the scope of these discussions and the quantum of due diligence to be undertaken by all parties, the Company considers that it will not be in a position to make full disclosure to the market of the relevant terms and conditions for a period of up to 7 days.

MIG has no other information necessary to inform the market about the Suspension.
