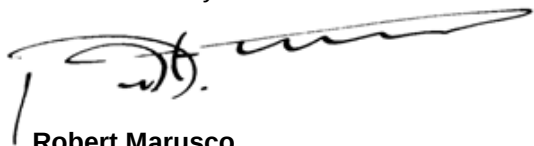
NOTIFICATION UNDER SECTION 708A(5)(E)

On 3 February 2017 Canyon Resources Limited ("CAY" or "the Company") issued 10,001,143 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 17 February 2017.
