## Exploration Update

**Mount Ridley Mines Ltd** (ASX: MRD) (or “the **Company**”) is pleased to announce an exploration update of the Company’s activities at its 100% owned Mt Ridley project in the Albany Fraser Range Province of Western Australia.

Regional ground gravity surveying is now complete. This data set has now been combined with the regional detailed magnetic and known geochemistry data to refine future primary exploration targets: Tyrrell’s, Keith’s, The Lake, Marcellus and Winston’s to date.

Due to the exceptionally unseasonal wet weather in the Esperance area, access to these primary targets has been temporarily halted. Exploration work testing these targets in the form of High Powered Moving Loop Electro Magnetic (HP MLTEM) and regional air core drilling has again commenced after an extended delay due to the wet weather.

Data collected to date prior to the unseasonal wet weather is being modelled and an announcement will be made on the completion of current activities, expected to be approximately two weeks.
