SECTION 708A NOTICE - SHARE ISSUE

Elk Petroleum Limited (ASX Code: ELK) Company hereby provides notice to the ASX for the purpose of section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**), that on 13 March 2017, in accordance with the Company's Convertible Loan Facility Agreement ("Facility"), in the amount of AUD\$12,342,105 (or USD\$9,380,000), the Company has agreed under the Facility to issue up to 119,826,264 fully paid ordinary shares in the capital of the Company at an issue price of A\$0.103. The ultimate issue of the noted shares will be dependent on whether the holders of Facility convert their loans into shares further to the terms of the Facility.

An Appendix 3B relating to the share issues is attached.
