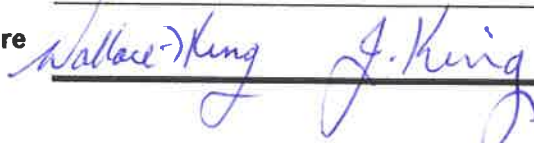

### DIRECTIONS
