1.1 Reasons for this Supplementary Prospectus

This Supplementary Prospectus has been prepared to extend the period for admission to quotation of Shares offered under the Prospectus from three months from the date of the Prospectus to three months from the date of this Second Supplementary Prospectus (**Quotation Condition**) pursuant to the ASIC Corporations (Minimum Subscription and Quotation Conditions) Instrument 2016/70 (**Instrument**).

The Company requires additional time to satisfy ASX that it has an appropriate spread of shareholders.

1.2 Quotation Condition

The Company makes the following statements regarding the Quotation Condition as required by the Instrument.

- (i) An application for admission to quotation of the Shares offered under the Prospectus was made within 7 days after the date of the Prospectus.
- (ii) The Shares offered under the Prospectus have not been admitted to quotation as at the date of this Second Supplementary Prospectus.

- (iii) ASX has indicated that the Shares offered under the Prospectus will be admitted to quotation subject to certain conditions (**Conditions**) being satisfied.

 - (b) applications for 150,000,000 Shares pursuant to the Vendor Offer.
