How to Vote on Items of Business

Each CHESS Depositary Interest (CDI) is equivalent to one share of Company Common Stock, so that every 1 (one) CDI that you own at Tuesday, 28 March 2017 entitles you to one vote.

You can vote by completing, signing and returning your CDI Voting Instruction Form.
