

## MADAGASCAR – TOAMASINA HIGH QUALITY GRAPHITE PROJECT UPDATE

- Second vendor payment of A\$200,000 to JV partner completed
- Drilling rig released from customs and now on site
- Construction of roads and dill pads commenced following Easter
- Drilling scheduled to commence on Monday, 24 April
- Drilling to focus on central 1km portion of 2.5km strike of graphite mineralisation, where previous trenching returned grades up to 25% Cgr

Cougar Metals NL (ASX Code: CGM) ("Cougar" or the "Company") is pleased to provide an update on progress at its Toamasina Graphite Project in Madagascar.

Access roads and drill pad construction has commenced, following the Easter holiday. Cougar's drilling rig has cleared customs, and is now on site. The drill crew is busy preparing the rig, workshop and accommodation facilities ahead of the scheduled start of drilling on Monday, 24 April.

The second payment to the project vendor was completed on 4 April 2017 and only a final payment of USD 150,000 remains due on 9 June 2017.

Cougar is pleased with progress made and would like to extend its gratitude to Joint Venture partner, DNI Metals, for its co-operation and assistance to date. A brief background on DNI Metals follows:

DNI Metals Inc. (CSE: DNI) ("DNI") is a listed Canadian public company which is an experienced graphite industry operator. In addition to being the owner of the Toamasina Graphite Project in Madagascar, DNI operates a graphite wholesale business, trading high quality graphite. In March 2017, DNI announced an agreement to deliver 2,320 metric tonnes of graphite to a customer's facility in USA.
