**ISSUE OF EXTERRA RESOURCES LIMITED SHARES – SECONDARY TRADING NOTICE
NOTIFICATION PURSUANT TO SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

On 27 April 2017, Exterra Resources Limited ("**Company**") issued 6,001,190 fully paid ordinary shares at an issue price of \$0.035 ("**Securities**").

Secondary Trading Exemption
