Notes Attached to this Report

After the successful settlement and internal review of the second half of the company's joint venture project during the December quarter, the board approached the March quarter in a perceptive manner. The weakening market conditions, specifically related to the WA housing market and project risks exacerbated by local councils has in the immediate term diminished the potential economic prosperity of the company's ventures, regardless of the approach i.e. through joint venture with large developers for the purpose of multiple dwelling projects and/or in our own right as we have successfully done so previously, incorporating steel framing construction.

While the company continued to seek and assess potential projects, few satisfied the company's enhanced due diligence process. Furthermore, the company remains operationally constrained due to its financial capacity. For this reason a capital raising remains in consideration by the Board, if deemed warranted, to assist in the pursuit of opportunities that will generate profits and potentially lead to a meaningful impact on the company's share price.

The major shareholders, investors and the bank continue to provide and offer ongoing support to the Company to create value for shareholders through its current strategy of smaller sized ventures incorporating steel framing construction. The company has had discussions with a corporate party, regarding the potential for working together, a merger of some sort, or formulation of any other structure that may benefit all parties within the same industry. In addition, the company is continually approached by parties inquiring about changes in principle business and a diversification away from Steel Framing Construction. However, these discussions remain at an early stage and if any progress eventuates with any of these parties we will advise the market after discussions with the ASX.

JV Global Ltd continues to be a very lean run company with minimal directors' fees and administration costs. This strategy will continue until the management can generate enough value to warrant any change.

The Board continues to look for other opportunities and or possible diversification of activities into other markets or sectors that could add value to the company, providing they can be pursued within the ASX listing rules, and fit within the Company's reward to risk ratio requirements. In the meantime, the Company has sufficient liquid and current assets to convert to cash, and access to funds if required, to meet its commitments, as and when required for the next 2 quarters.
