## RGI Signs Heads of Agreement with Amfil Technologies Inc. for GROzone Antimicrobial Systems

- RotoGro sign Heads of Agreement with Amfil Technologies Inc. (OTC:AMFE)
- Amfil commences work to integrate Amfil's proprietary GROzone Antimicrobial System with the RotoGro Unit
