## South Johnstone Update and Hemp Interview on ABC with Andrew Kavasilas

The board of Queensland Bauxite Limited (ASX: QBL, the Company) announced on Wednesday 26<sup>th</sup> April that there would be a meeting regarding the South Johnstone bauxite project in Cairns with the aim of resolving outstanding environmental matters so that its MDL (Mineral Development Licence Application) can be granted for the bauxite project at South Johnstone.

The meeting is scheduled to take place tomorrow, Friday 5<sup>th</sup> of May between representatives of the Department of Environment and Heritage Protection (DEHP) and representatives of the Company led by Dr. Robert Coenraads Chief Geo-Scientist of QBL, and the Company's environmental consultants Northern Resources and engineers Sea Transport. It is intended that this meeting will pave the way to resolve residual issues so that the MDL can be progressed and granted after considerable waiting by the Company and its shareholders. The Department has assured QBL that it is there to assist us in achieving the grant.

Meanwhile the Cannabis and Hemp front in Australia, and in particular for our Company, is progressing significantly, especially with the historic approval last week for Hemp Seed food to be approved for legal human consumption in Australia. This is of significant commercial significance for our Company, as MCL is in the forefront of being able to capitalise on this major development as detailed in our announcement of last Friday 28<sup>th</sup> April.
