Issue of Shares and Unlisted Options

Acacia Coal Ltd (**Company**) confirms the Company has today issued a total of 21,666,667 Ordinary Shares (of these Ordinary Shares 16,666,667 are held in a voluntary holding lock for 6 months; until 22 November 2017) and 2,500,000 unlisted options exercisable at \$0.006 expiring 4 December 2021.
