Issue of Shares in Lieu of Fees Totalling \$280,000

Frontier Resources Limited (**Frontier** or the **Company**) is pleased to announce that it has agreed with consultants and contractors to the Company to settle future 2017 fees in shares.

The Company's professional consultants and contractors, have agreed to settle fees totalling \$280,000 in shares at conversion price of \$0.045 per share (**Conversion**).

Frontier currently has no existing debt with these consultants and contractors and the Conversion represents approximately six months of professional fees for future services in Papua New Guinea (**PNG**) and Australia.

The Directors note that the Conversion is an efficient way of enabling exploration to be undertaken in PNG and are very encouraged that these parties are pleased to participate in the Company's future in this manner.

This Conversion will provide the Company the flexibility to save a substantial amount of budgeted expenditure from future exploration programs.
