**ISSUE OF MINDAX LIMITED SHARES – SECONDARY TRADING NOTICE NOTIFICATION  
PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Act)**

On 26 May 2017 Mindax Limited (**Company**) issued 5,000,000 fully paid ordinary shares at an issue price of \$0.005 per share (**Securities**).

**Secondary Trading Exemption**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.
