## **Monadelphous Contracts Update**

Engineering company Monadelphous Group Limited (ASX:MND) ("Monadelphous" or "the Company") today announced it has secured new contracts and additional work with a combined value of approximately \$125 million.

The Company has been awarded a subcontract for structural, mechanical, piping, electrical and instrumentation work for Kawasaki Heavy Industries on the cryogenic tanks at the Ichthys Project Onshore LNG Facilities in Darwin.

New work has been secured in North America by SinoStruct, Monadelphous' fabrication business, with an order to supply structural steel, fabricated spooling and preassembled modular pipe racks for Jacobs, as part of a plant expansion project in the US.

The Company has also secured four new contracts in the water industry, one in Australia and three in New Zealand ("NZ"), including:

- A contract for all works including civil, structural, mechanical and electrical works associated with the upgrade to the Cleveland Bay Purification Plant for Townsville City Council;
- Two contracts for Hastings District Council for the construction of a new sewer pipeline, water main and ancillary items in the Havelock North township and a new water main in Hastings City, NZ; and
- A construction contract for an upgrade to a wastewater treatment plant for Selwyn District Council in Rolleston, NZ.

"We are particularly pleased to have secured further works at Ichthys, which underlines our strong performance to date on this project," Monadelphous Managing Director Rob Velletri said. "The award of the fabrication contract represents a strategic milestone in SinoStruct's North American market entry strategy and the new water contracts extend our presence in the Australian and New Zealand water industries."
