**BCP Energy International Pte. Ltd. compulsory acquisition of Nido

We confirm that we act for BCP Energy International Pte. Ltd. (**BCPE**).

We refer to the compulsory acquisition of the ordinary shares and retention rights issued in Nido Petroleum Limited (**Nido**) announced to the market on 10 May 2017 (**Compulsory Acquisition**).
