**EXERCISE OF OPTIONS
NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT**

The Directors of 88 Energy Limited ("**the Company**") provide a notice for the purposes of section 708A(5)(e) of the Corporations Act 2001.
