Share Placement Notice Under ASX Listing Rule 3.10.5 and Section 708A of the Corporations Act and Appendix 3B

Following on from its announcement 5 July 2017 Inca Minerals Limited (**Inca** or **Company**) is pleased to advise it has successfully completed the share placement (referred to in the aforementioned announcement) and issued 18,212,110 fully paid ordinary shares in the Company (**Placement**). The requisite Appendix 3B is attached to this announcement.

The Placement raised \$250,000 (net of raising costs) with funds to be directed towards exploration at Inca's Riqueza Project in Peru and/or for working capital.

Inca provides the following information pursuant to ASX Listing Rule 3.10.5 and Section 708A(5)(e) of the Corporations Act.

The Placement shares were issued without disclosure to Acuity Capital under Part 6D.2 of the Corporations Act using Inca's share placement capacity as approved by shareholders at the Company's Annual General Meeting on 29 November 2016 and pursuant to ASX Listing Rule 7.1A. As at the date of this notice Inca has complied with:

- (a) The provisions of Chapter 2M of the Corporations Act;
- (b) Section 674 of the Corporations Act; and

there is no excluded information for the purposes of Sections 708A(7) and (8) of the Corporations Act.
