CLEANSING NOTICE

This notice is given by Breaker Resources NL (**Company**; ASX: BRB) under Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Company hereby confirms that:

- (a) it has issued 385,482 fully paid ordinary shares (**Shares**) at a deemed issue price of \$0.678 per Share to Ausdrill Limited (or their nominated entity; a sophisticated or professional investor) in lieu of cash payment for drilling services undertaken at the Company's Lake Roe Project;
- (b) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
