RESULTS OF THE GENERAL MEETING AND SPECIAL MEETING

PERTH, WA: DEPARTMENT 13 INTERNATIONAL LTD (ASX:D13) ("Department 13", "D13" or "the Company"), held the General Meeting of Shareholders and Special Meeting of the Performance Shareholders today 11:00am and 11:30am respectively at Level 13 60 Castlereagh Street Sydney NSW 2000.

Valid proxies received 51, representing 58,045,100 ordinary shares, being 11.3% of the Company's issued capital.


Special Meeting of Performance Shareholders
