NEAR-SURFACE, HIGH GRADE GOLD ZONE EXTENDED AT LADY ADA DEPOSIT, FORRESTANIA GOLD PROJECT, WA

Highlights:

• Drilling at Lady Ada has returned spectacular high-grade results from outside the current Scoping Study pit design, highlighting significant potential to expand current Mineral Resource estimate at FGP (refer to ASX announcement dated 14th March 2017)

Additional results (for Lady Ada only) include:

- MARC001: 9m @ 6.23 from 36m including 6m @ 9.06, and 2m @ 15.74 from 37m (new zone)

- Intersected high-grade zone remains open at depth and along strike, warranting further follow up drilling. This will be aggressively targeted, along with the SE-plunging depth extension at Lady Ada reported in ASX announcement dated 5 July 2017.
- Scale of alteration and mineralisation observed in all holes drilled to date continues to be indicative of a potentially large-scale gold system
- Further assays for Lady Magdalene drilling expected to be received imminently

I. INTRODUCTION

WA-focused gold exploration and development company Classic Minerals Limited (ASX. CLZ) ("Classic", or "the Company") is pleased to advise that it has received additional assay results for the initial holes drilled at the Lady Ada deposit as part of the Phase I drilling program at the Company's Forrestania Gold Project ("FGP") in Western Australia.

MARC001 was a standout hole which yielded very impressive, high-grade gold mineralisation at a shallow depth (38m) in an area that is outside of the current optimised pit design.

The strong results support the work that is currently planned to upgrade the Mineral Resources at the Forrestania Gold Project. The drilling was designed to target mineralisation outside of the current resource model as well as high-grade extensions below -and adjacent to- the current pit design. This is in line with Classic's strategy to sufficiently grow its Mineral Resources to a size that supports establishment of an on-site processing facility at FGP, as assessed in FGP Scoping Study (see ASX announcement released 2nd May 2017).

The Reverse Circulation (RC) drill program drilled to date comprised a total of 18 holes for 3,670m (MARC001 - MARC018), of which eight holes were drilled at Lady Ada. Additional results are presented for three holes (MARC001 - MARC003). Assay results for the remaining intersections and holes are expected to be announced as they are received.

An additional POW ("Program of Works") was lodged with the DMP ("Department of Mines and Petroleum") for an in-fill and extensional drilling program. This has now been approved, allowing Classic to rapidly move to the next phase of exploration and development at the FGP. The Company will update the market accordingly.

Classic's Managing Director, Justin Doutch, commented:

"Lady Ada is a stacked, shallow-dipping ore body which is open at depth and along strike. These latest assay results are very exciting, as they suggest that one of the near-surface lower grade zones has high-grade extensions, reaffirming our view that the Forrestania Gold Project potentially hosts a much larger gold system.

We see this as a great opportunity to increase the Mineral Resource at Lady Ada, but also, in the longer term, improve the project economics as pre-stripping for the planned cut-back may now be able to incorporate some of this high-grade material into the mine design.

Lady Ada now has several follow up exploration target zones, and with drilling approvals already in place, further drilling around this particular hole is planned to ascertain the extent of the zone.

This is a great result for our Phase I exploration campaign at the Forrestania Gold Project and we are looking forward to reporting the subsequent Lady Magdalene assay results in the coming weeks. Our success at Lady Ada gives us confidence that drilling at Lady Magdalene will also confirm the existence of potentially economic mineralisation trending SE at depth."

2. ABOUT THE FORRESTANIA PROJECT

The FGP Tenements are registered in the name of Reed Exploration Pty Ltd, a wholly owned subsidiary of ASX listed Hannans Ltd (ASX:HNR). Classic has acquired 80% of the gold rights on the FGP Tenements from a third party, whilst Hannans has maintained its 20% interest in the gold rights. Hannans' 20% interest is free-carried, meaning Hannans is not required to fund any activities on the FGP until a decision to mine has been made. For the avoidance of doubt Hannans Ltd owns a 100% interest in non-gold rights on the FGP Tenements including but not limited to nickel, lithium and other metals.

The Forrestania Gold Project contains an existing Mineral Resource of 5.9 Mt at 1.25 g/t for 240,000 ounces of gold, classified and reported in accordance with the JORC Code (2012), with a recent Scoping Study (see ASX Announcement released 2nd May 2017) suggesting both the technical and financial viability of the project. The current post-mining Mineral Resource for Lady Ada, Lady Magdalene and Lady Lila is tabulated below. Additional technical detail on the Mineral Resource estimation is provided, further in the text below and in the JORC Table I as attached to ASX announcements dated 14th March 2017 and 21st March 2017.

3. DRILLING AT LADY ADA - CONFIRMING RESOURCE DEVELOPMENT MODEL

Upon first examination of the generally east-dipping mineralisation, the mineralisation appears to be diminishing at depth. However, when the high-grade intervals (>5.0 g/t Au) are displayed in plan-view (see appendix 2 of ASX Announcement dated 14 March 2017) a south-easterly plunging trend is readily observable. When cross-sections are created parallel to the high-grade plunge, it is clear the mineralisation is open at depth as shown in the oblique -and cross sections provided in Figures 2 & 3.

The mineralisation at Lady Ada is hosted within the Sapphire Shear, which presents as two zones of stacked shallow dipping faults. The grades within the shear are variable (typical of shear hosted systems) and present commonly as intervals of 2-3 m, with average grades frequently ranging up to 5.0-15.0 g/t Au. Figure 2 and Figure 3 show high-grade intercepts that have not been closed off at depth. The main (eastern) high-grade part of the Mineral Resource is 55 m wide with a down-dip length of 230 m; the second (western) high-grade part of the Mineral Resource is approximately 35 m wide with a down-dip length of 170 m (as first reported in the ASX announcement from 9 March 2017).

MARC002 and MARC003 hit wide zones of mineralisation, which appear to be an extension to one of the flatter lying mineralised zones, which also continues along the same general SE direction. Assays for the deeper zone that was targeted by MARC002 and MARC003 (see Figure 2) have not been returned yet.

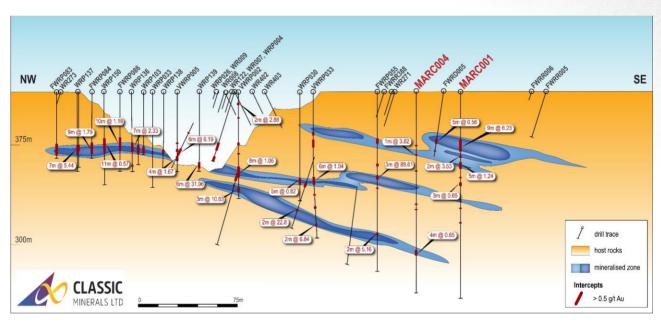


Figure 1: Lady Ada cross section looking north east showing CLZ drill holes MARC001 and MARC004

MARC001 showed significant mineralisation near surface (including 6m @ 9.06 and 2m @ 15.74 from 38m) and this zone is interpreted as a higher grade extension of the uppermost flatter dipping zones (Figure 1). It is evident from reviewing all drilling results that seemingly low-grade zones may taper into, or include significant high-grade and wide zones. CLZ is carrying out additional sampling at MARC004 and other holes where close-to-surface intervals were not assayed, to add to geological understanding.

Classic's next drilling programme will focus on infill drilling to upgrade – and on extension drilling to extend – the existing Mineral Resource. Based on recent interpretations, part of the drilling will also focus on new targets directly adjacent to Lady Ada and Magdelene deposits.

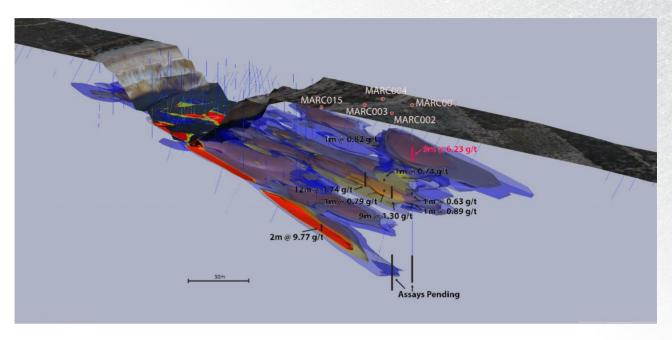


Figure 2: Lady Ada oblique section looking North, showing the implicit mineralisation model and the exploration drilling results.

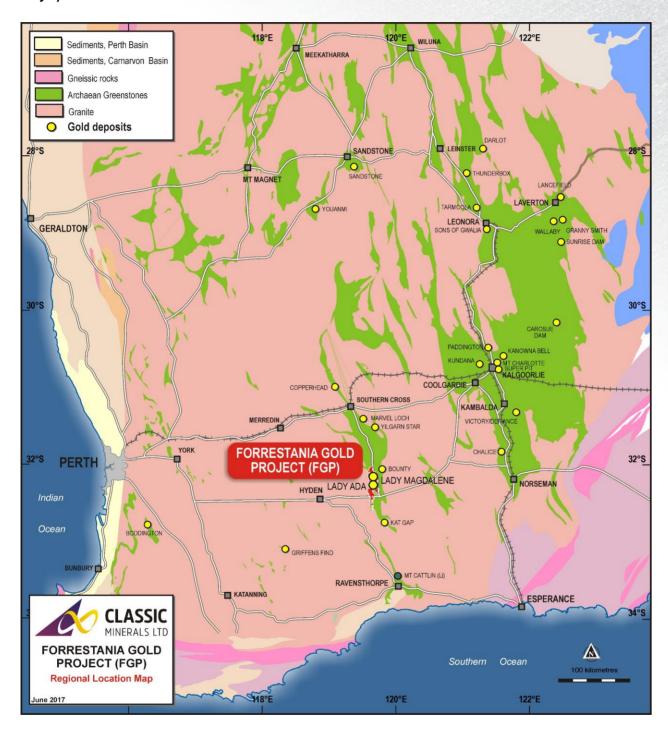


Figure 3: Regional Map

A number of narrow shear zones lie subparallel to the shallow-dipping metasediment-mafic contact within the host stratigraphy and are important sites and conduits for the observed mineralisation. The Sapphire shear zone strikes approximately ENE, dipping to the SE at about 25°, and appears to crosscut all lithologies. This shear zone and associated shears host the bulk of the gold mineralisation at Wattle Rocks. Similar flat-dipping shears are known to crosscut the Lady Magdalene area. Approximately 8-12 metres of transported sands and a gold depleted weathering profile of saprolitic clays overly the Lady Ada and Lady Magdalene mineralisation. Structurally, the Wattle Rocks area is quite complex and is positioned near the intersection of several major breakages and flexures in the regional stratigraphy in this part of the Forrestania Greenstone belt. Numerous shear zones are evident throughout the area, particularly at changes of rock stratigraphy where there are rheological differences. Narrow, stacked, flat-dipping shear zones are evident within the quartz dolerite unit and may have resulted from thrusting of the younger sedimentary sequence over the mafic package from east to west.
