

QUARTERLY ACTIVITIES REPORT

FOR THE PERIOD ENDING 30 JUNE 2017

Torian Resources Ltd (**Torian** or **Company**) (**ASX:TNR**) is pleased to announce its quarterly activities report for the period ended 30 June 2017 which was yet another busy quarter for the Company.

During the quarter the Company undertook a placement of A\$1.2 million to sophisticated investors, completed the takeover of Cascade Resources Limited and commenced drilling at Paradigm East, part of the Zuleika project. The Company also released its operational strategy for 2017/18 showing how the Board intended to grow the business over the next 12 months.

This strategy provides new investors with leverage through exploration and discovery, forming potential partnerships with other resources companies, exploiting existing development options and to a rising gold price.

During the quarter, the Company has also had a number of approaches by parties interested in discussing commercial terms on the Company's projects. At this stage, none of these have been finalised.

1. 2017/18 Strategy

Overview:

- Stage 1 of Torian's five year strategic plan (Acquisition Stage) is complete and stage 2 (Leverage Stage) now has commenced;
- Committed exploration programs for FY2018 include Paradigm East (Zuleika Project), Paradigm North (Zuleika Project) and Calypso (Malcolm Project);
- Exploration and production JV discussions on numerous projects are now underway;
- Torian continues to assess various producing assets that have the potential to generate cashflow for the Company; and

 The strategy is designed to leverage Torian's large and strategic land package and generate value for shareholders.

The Vision:

From humble beginnings, Torian has evolved into a highly active gold exploration and development company with big plans. Torian's vision is to become a mid-tier gold producer within five years.

The Projects:

Torian has eight gold projects located in the Goldfields Region of Western Australia. The Company's projects range from greenfield to pre-development stage. These projects are strategically located within 50km of gold processing hubs, delivering Torian and potential new partners a diversified portfolio that can be used to grow a footprint in the most well-endowed gold jurisdiction in Australia. This portfolio provides new investors with leverage through exploration and discovery, exploiting existing development options and to a rising gold price.




Figure 1: Map showing Torian's suite of gold projects in Western Australia.

The Strategy:

In order to achieve Torian's vision to become a mid-tier gold producer within 5 years, Torian's strategic plan encompasses a number of key steps including:


- Committed exploration programs;
- Production joint ventures;



- Exploration joint ventures; and/or
- Asset acquisitions.

2. Exploration

During the quarter the Company continued preparation of various exploration programs across all projects. The emphasis was placed on the highest priority targets, such as The Zuleika Project. The Company's technical team has reviewed a number of opportunities for acquisition with the aim of adding to the existing portfolio of tenements or a new project that could potentially deliver cash flow.

The Company has had a number of approaches by parties interested in discussing commercial terms on the Company's projects. At this stage none of these have been finalised.

Paradigm East:

During the quarter, the Company commenced drilling at Paradigm East. Paradigm East is located towards the northern end of the Company's 100% owned Zuleika Project, approximately 65km North West of Kalgoorlie. The program was designed to test high-grade historic intersections adjacent to Northern Star's Paradigm mine and their significant recent discoveries.

The drill program was completed post end of the quarter and the results have subsequently been announced.






Figure 4: Map showing Torian's Zuleika Project, the Paradigm mine (Red Circle) and other major gold miners.

The drill program comprised seven holes for a total of 526 metres and was designed to infill the central portion of Paradigm East to a spacing of 20m by 40m. The holes were sampled as 4m composites however single metre samples have now been submitted to the lab for assay.






Figure 5: Map showing a plan view of Torian's Paradigm East Prospect.

Results to date show that gold mineralisation continues from Northern Star's (ASX:NST) Paradigm Prospect onto Torian's Zuleika Project tenure at Paradigm East and remains open at depth and along strike to the south east. There are also several other high priority targets surrounding Paradigm, particularly to the north and south, that have only been lightly explored. Further exploration is warranted and the Company has already commenced planning for the next exploration program at Paradigm East.






Figure 6: Cross section at Paradigm East.

3. Corporate:

Cascade Takeover:

During the quarter, Torian completed the off-market Takeover of Cascade Resources Ltd (**Cascade**). Cascade is now a wholly owned subsidiary of Torian. As a result, Torian is now:

- A significant player in the Goldfields Region with over 500km² of tenure;
- The 100% owner of the strategically important Zuleika project (previously 12.25%);
- The owner of four additional projects including Mt Keith, Mt Monger, Kanowna South and Five Mile Hill projects; and
- Has added to existing tenure at the Company's Bardoc project (~30.2km²).



Completion of this significant transaction has simplified the ownership structure of all projects and has delivered on the Company's strategy of further consolidation in the Goldfields Region of Western Australia.

Following completion of the Cascade Transaction, Mr. Glenn Jardine resigned as a non-executive director of the Company. Mr. Jardine joined the board as an independent director to assist with the Transaction.

Capital Raise:

On 1 May, the Company announced the completion of a A\$1.2 million placement to sophisticated and professional investors.

The equity raising received demand from two new US institutions. APP Securities Pty Limited acted as the Lead Manager to the placement and Jett Capital as North American advisor.

Approximately 11 million ordinary shares were issued for the capital raise at 10.5 cents per share. The placement was conducted utilising Torian's placement capacity as approved by Shareholders at the 2017 Annual General Meeting.

About Torian:

Torian Resources Ltd (ASX:TNR) is a highly active gold exploration and development company. Following the acquisition of Cascade Resources Ltd on 23 May 2017, the Company has a large and strategic landholding comprising eight projects and over 500km² of tenure located in the Goldfields Region of Western Australia.

Torian's flagship project, Zuleika, is located along the world class Zuleika Shear. The Zuleika Shear is the fourth largest gold producing region in Australia and consistently produces some of the country's highest grade and lowest cost gold mines. Torian's Zuleika project lies north and partly along strike of several major gold deposits including Northern Star's (ASX:NST) 7.0Moz East Kundana Joint Venture and Evolutions (ASX:EVN) 1.8Moz Frogs Legs and White Foil deposits.

The Zuleika Shear has seen significant corporate activity of late with over A\$1 Billion worth of acquisition in the region by major mining companies. Since May 2015, Torian has increased its landholding by approximately 86% along the Zuleika Shear via eight separate acquisitions. The total land position at the Zuleika project is now approximately 223km² making Torian the second largest landholder in this highly sought after region.

Torian's exploration team has an enviable track record of exploration success which includes the discovery of some of Australia's largest gold mines. Last year Torian drilled 59,345m for a total of 1,319 holes across its projects. The large drilling campaign tested 26 exploration targets and, importantly, made four gold discoveries. This makes Torian one of the most active gold explorers on the ASX.

2017 is set to be another big year for the company. As one of the ASX's most active gold explorers we offer new shareholders significant leverage to exploration success.
