
CLEANSING NOTICE
NOTIFICATION UNDER SECTION 708A(5)(E)

On 24th of August 2017 NTM GOLD Ltd ("**NTM**" or "**the Company**") issued 3,254,118 fully paid ordinary shares (the **Shares**) to Ausdrill. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 23 August 2017.

The Company gives notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that:
