He was also Cisco's Sales Director, Service Sales, for three years - based in Singapore. In this role, Mr Barker was responsible for establishing and maintaining Service Sales for the Company's Tier-1 accounts and developed a services group to implement and maintain new product introduction and solution support.

He also served in the roles of Director, Public Sector and Client Director, Telstra whilst at Cisco.

At Oracle, Mr Barker was Systems Vice President – Australia and New Zealand, where he managed the systems group across Australia and New Zealand and was a member of Oracle's senior leadership team. In this role, he rebuilt the Company's sales team and developed and executed the strategic plan for the territory and was responsible for delivering and sustaining profitable revenue streams across a broad product portfolio.

Most recently, he was Managing Director of VCE – a joint collaboration between Cisco, EMC and VMWare and known as the Converged Platform and Solutions Division of Dell EMC.

Mr Barker's appointment is part of an overall corporate restructure as the Company's commercialisation efforts gain momentum. As part of this restructure, Quantify Technology has reduced overheads in a number of areas to ensure it is focusing resources on its sales and marketing efforts.

In the new role, Mr Barker will be responsible for overseeing Quantify Technology's day-to-day operations, including its Sales, Marketing, Engineering and Operations divisions.

"I am very excited about Quantify Technology's prospects and pleased to be joining the firm in a full-time role.
