#### COMPANY UPDATE

- **Battery Hub manganese tenement grant in final phase**
- **Soil sampling program completed at Morrissey Hill lithium-tantalum project**
- **Surface mapping and sampling completed at Mount Boggola copper prospect**
- **Well-funded to pursue exploration programs at Battery Hub and other projects**

**Pure Minerals Limited** (ASX: PM1) (“Pure Minerals” or “the Company”) is pleased to provide an update of its corporate and exploration activities that have taken place since the Company listed in early August, 2017.

#### **Battery Hub Manganese Tenement -- Grant Update**

The Native Title Tribunal has formally notified the Western Australian Department of Mines, Industry Regulation and Safety (DMIRS) that it has received no objections from Native Title claimants during the four-month objection period ending 19<sup>th</sup> August 2017. The grant process for E09/2217 is now in the final phase of assessment for determination under the Mining Act, and the Company expects the grant to occur in the near term.

Once E09/2217 is granted, the 100%-owned Battery Hub project will be a priority target for Pure Minerals due to its large size and prospectivity for manganese mineralisation. Numerous manganese prospects occur along the entire strike length of the host formation, many with surface samples and drill hole intercepts exceeding 40% Mn.

Pure Minerals has continued site visits and reconnaissance at the Battery Hub project, along with a review of historic exploration data, with a view to initiating a drilling program at the project as soon as practicable following grant of the tenement.

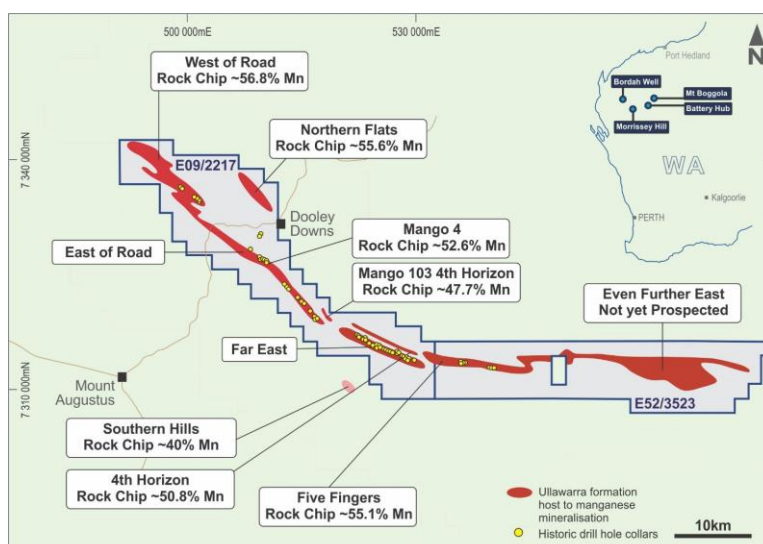


Figure 1: Location of Battery Hub project including significant surface samples

### Morrissey Hill Lithium Prospect -- Soil Sampling

Pure Minerals has recently completed a soil sampling programme at its 80%-owned Morrissey Hill lithium-tantalum project in the Gascoyne region of Western Australia. Samples have been submitted to ALS Global laboratories in Malaga, Western Australia, for analysis.

The survey is designed to provide an initial test of a geological terrane where abundant and thick pegmatites have been recorded and mapped by historical explorers which have not previously been systematically tested for lithium mineralisation.

### Mount Boggola Copper Prospect -- Mapping and Surface Sampling

Reconnaissance mapping and rock chip sampling at its 80%-owned Mount Boggola copper prospect in the Pilbara region of Western Australia has been undertaken. Samples have been submitted to ALS Global Laboratories in Malaga, Western Australia, for analysis.

Following the recent \$4.5 million capital raising, Pure Minerals is well funded to continue to aggressively pursue its exploration plans at Battery Hub and its other projects in the Gascoyne and Pilbara regions of Western Australia.
