Monadelphous Contracts Update

Engineering company Monadelphous Group Limited (ASX:MND) ("Monadelphous" or "the Company") today announced it has secured new maintenance and construction work in the mining and minerals and oil and gas sectors with a combined value of approximately \$220 million.

The new maintenance work comprises:

- A two year contract to supply fixed plant maintenance services for Rio Tinto at its coastal and part of the inland operations in the Pilbara. The work is a continuation of existing work with Rio Tinto.
- A 12 month contract extension on the Woodside-operated Karratha Gas Plant Life Extension Program through its joint venture MGJV, which includes the delivery of mechanical, electrical, access, coatings and insulation services.

New construction work comprises:

- A contract to provide electrical and instrumentation construction works associated with the Shaft 2 Surface Facilities for the Oyu Tolgoi Underground Project located in the South Gobi region of Mongolia. This is the second package of work awarded to Monadelphous on this project, and is scheduled for completion in September 2019.
- An additional order secured by Monadelphous' China-based fabrication business, SinoStruct, from Santos for the supply and fabrication of wellhead skids as part of its upstream coal seam gas development in northern Queensland.

Managing Director Rob Velletri said "We are pleased to have been awarded new and extended contracts with a number of existing customers, which reflects our focus on building and maintaining long term customer relationships through continuous improvement in service delivery."
