- Delivery of a pump station to Metro Mining for deployment at the Skardon River project in Queensland
- Delivery of a chemical dosing system to M&K Pipelines QLD Pty Ltd, a Queensland-based small to medium sized company (SME)
- A short-term operations and maintenance agreement with a luxury resort on Hayman Island, Queensland. Under the contract, Akwa Facility Maintenance will operate the water and sewage treatment plants in the resort for a period of three months

These projects will start immediately.
