#### CORPORATE GOVERNANCE STATEMENT

This Corporate Governance Statement is current as at 27 September 2017 and has been approved by the Board of the Company on that date.

This Corporate Governance Statement discloses the extent to which the Company currently follows the recommendations set by the ASX Corporate Governance Council in its publication Corporate Governance Principles and Recommendations (**Recommendations**).
