## Roto-Gro Receives Initial Order from Amfil Technologies Inc. for 100 Roto-Gro Systems

- Roto-Gro receives an initial purchase order for 100 Roto-Gro Systems from Amfil Technologies Inc.
- The order will facilitate the first phase of an emerging Canadian cannabis cultivator's planned 40,000 sq.ft. new facility buildout
- The Company is in discussions with the Cultivator's team to design a propriety rotary garden solution for its perishable food operations

Roto-Gro World Wide (Canada) Inc., a wholly-owned subsidiary of Roto-Gro International Limited ("**ASX:RGI**", "**Roto-Gro**" or the "**Company**"), is pleased to announce it has received a purchase order for 100 Roto-Gro Systems (the "**Purchase Order**") from Amfil Technologies Inc. (**OTC:AMFE** or "**Amfil**"). The Purchase Order builds on the existing collaborative relationship with Amfil for the integration of Amfil's proprietary GRO<sub>3</sub> Antimicrobial System with the Roto-Gro System, providing enhanced cultivation solutions for medical cannabis and indoor farming industries.

The successful signing of the Purchase Order is a result of the diligent collaboration of Roto-Gro and Amfil over the past 5 months. This collaborative effort has resulted in an impressive pipeline of prospective clients seeking the significant space, cost and yield advantages of the Roto-Gro System together with Amfil's EcoPrO<sub>3</sub> GRO<sub>3</sub> all-natural solution to the contamination issues recently plaguing the medical cannabis industry.

The 100 Roto-Gro Systems will be stacked two-high in 4,000 sq.ft. of the first phase of the buildout of an estimated 40,000 sq.ft. facility to be developed by a soon-to-be-licensed Canadian cannabis cultivator which plans to produce organic cannabis products in Ontario, Canada (the "**Cultivator**"). The total purchase price for the Purchase Order is approximately C\$1.1m, with delivery expected to commence by the end of the year.

In addition, the Cultivator also operates a non-cannabis related nursery of perishable foods covering approximately 150,000 sq.ft. contained in several buildings on a single property. The Company is currently discussing the design of a propriety rotary garden solution for the Cultivator's perishable food operations and will assist the Cultivator with a staged roll-out of a portion of
