Director's Change of Interest - Amendment

The audit of South Pacific Resources Limited (ASX: SPB) has brought to the Company's attention an error in the Change in Director's Interest Notice (Appendix 3 Y) for Mr Alvin Tan lodged on 24 October 2016. The error in the Appendix 3Y lodged on 24 October 2016 was an administrative oversight.

- Dissemination to directors of the Company's securities trading policy;
- Support of the Company Secretary to assist directors to meet their obligations;

The Company's existing arrangements are considered adequate and the Company and its Directors remain aware of their obligations under ASX Listing Rule 3.19A and 3.19B in relation to notifiable interests.
