YOJEE LIMITED – MARKET UPDATE

Yojee Limited (**Yojee** or the **Company**) (ASX: YOJ) refers to its announcement to ASX on 4 October 2017 titled "*Yojee Moves to Bulk Freight and Wharf Cartage with Industry Leader*" and provides the following additional clarifying information:

- Digital information packages are offered by Yojee to support adoption to larger companies, and include white labelling (reskinning to customers branding) and initial phase of implementation, focusing on optimal efficiency, with support from Yojee's in-house experts.
- The 4 October announcement refers to the signing of the Company's first digital transformation package with an industry leader specialising in wharf cartage and bulk freight across Australia. The industry leader is Tasman Logistics Services Pty Ltd. The roll-out of the package to Tasman Logistics Services Pty Ltd is immediate as an initial phase of implementation.
- All orders of Yojee's digital transformation package involves payment of an initial implementation fee. Following the initial phase of implementation, Yojee further evaluates the possibility of implementing its software application into the customer's business operations. If an agreement is reached, the revenue model will then be subscription based model following further customer engagement. The potential financial impact of ongoing use of the software would be in-line with other commercial software sales, although it is not quantifiable at this point in time.
