RE: SMARTTRANS HOLDINGS LIMITED - REQUEST FOR TRADING HALT

Pursuant to ASX Listing Rule 17.1, SmartTrans Holding Limited (ASX: SMA) (**SmartTrans**) requests an immediate trading halt be granted by ASX Limited (ASX) with respect to its listed securities with immediate effect.

The trading halt is requested in connection with a potential material acquisition by SmartTrans.

The following information is provided in accordance with Listing Rule 17.1:

- 1. **Reason for trading halt** to allow the ASX to consider the Company's announcement dated 16 October 2017.
- 2. **Duration of the trading halt** SmartTrans expects the trading halt will last until it makes an announcement to the ASX concerning the outcome of the ASX's enquiries, which it expects to make before the commencement of trading on Wednesday 18 October 2017.
