De.mem Wins New Contract Worth A\$250,000

- De.mem secures new contract from municipality in Queensland, Australia

31 October 2017: Water and waste water treatment company De.mem (ASX:DEM) ("De.mem" or "the Company") is pleased to announce that it has secured a contract worth approximiately A\$250,000 from Maranoa Regional Council, Queensland. The project has been awarded to the company's 100% owned subsidiary Akwa-Worx Pty Ltd, Caboolture, Queensland, Australia.

De.mem's scope of work includes the delivery and installation of re-chlorination systems for a municipal drinking water reservoir. The project starts immediately with implementation planned to be completed prior to year-end.

The contract award brings the total contracts awarded in the last three months to approximately A\$1.05 million. De.mem secured an A\$500,000 contract to sell a water treatment plant in Vietnam in August 2017 and \$A300,000 of new contracts in Queensland following its Akwa-Worx acquisition in September 2017.

These contracts further reinforce the significant progress that the Company has made since listing on the Australian Securities Exchange (ASX) in April 2017.

The Company is continuing to pursue a number of opportunities in its key growth markets including Australia, Singapore, Malaysia and China.

Andreas Kroell, Chief Executive Officer of De.mem: "We are delighted with the momentum we have gathered in the last three months. Winning these contracts further positions De.mem for growth and provides the opportunity to rollout of our innovative nanofiltration membrane technology. Through our acquisition of Akwa-Worx we have increased De.mem's presence in Australia and we are excited about the Company's continued expansion."
