**Request for trading halt: Bubs Australia Limited (ASX: BUB)**

Bubs Australia Limited (**Bubs**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares from the commencement of trading on Wednesday, 1 November 2017. The trading halt is requested pending an announcement by Bubs in relation to a proposed acquisition and an associated proposed capital raising.

In accordance with ASX Listing Rule 17.1, Bubs provides the following information:

- (a) Bubs requests that the trading halt continue until the earlier of commencing of normal trading on Friday, 3 November 2017 and when the company makes an announcement to the market and requests the trading halt be lifted;
- (b) Bubs is not aware of any reasons why the trading halt should not be granted; and
- (c) Bubs is not aware of any other information to inform the market about the trading halt.
