
CLEANSING NOTICE
NOTIFICATION UNDER SECTION 708A(5)(E)

On 13th of November 2017 NTM GOLD Ltd ("**NTM**" or "the **Company**") issued 6,823,420 fully paid ordinary shares (the **Shares**) to Ausdrill. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 10 November 2017.
