

RC DRILLING RESULTS UPDATE

SINGLE METRE ASSAY RESULTS CONFIRM AND UPGRADE

Emerging Goldfields explorer NTM Gold Limited (ASX: NTM) ("NTM" or the "Company") is pleased to announce that it has now received the single metre RC drilling results from exploration drilling at the Company's 100% owned Redcliffe Gold Project, located near Leonora in Western Australia.

Single metre assay results have confirmed and upgraded the five metre composite results announced on 24 October 2017. RC drill holes at the Nambi, GTS and Bindy, have highlighted high grade target areas that are now currently being drill tested. Single metre results include:

NAMBI DEPOSIT*

Exciting new high grade gold target, E2 Lode enhances potential for additional high grade at shallow depth

4m @ 21.0g/t (Inc. 1m @ 67.0g/t) 6m @ 2.60g/t (Inc. 1m @ 9.89g/t)

High grade gold intercepts have extended the consistent Main Lode below the 400m long open pit.

4m @ 10.1g/t (Inc. 2m @ 16.25g/t) 5m @ 5.30g/t (Inc. 1m @ 18.9g/t)

Drilling at Nambi aiming to extend the mineralised zones at depth is currently in progress.

GOLDEN TERRACE SOUTH (GTS) DEPOSIT

High grade zones within mineralised intervals are to be further tested in current drill programme. Mineralization remains open down plunge to the south.

REGIONAL TARGETS - BINDY & KELLY TREND (KT) PROSPECTS

First pass wide spaced RC drilling shows potential for high grade intervals within broad mineralised zones and Bindy and KT to be further tested in current RC programme.



A total of 31 inclined holes for 5,460m were completed. Drilling targeted extensions to high grade lodes beneath the Nambi and GTS deposits as well as first pass, wide spaced, RC drilling at the newly discovered Bindy Prospect. (Drilling at Bindy has been completed on 100m spaced traverses.)

The single metre results have further enhanced the prospectivity of the mineralised zones drilled, highlighting the potential for high grade zones at depth.

Nambi Deposit

Drilling at Nambi successfully intersected extensions to the high grade zones which remain open at depth and down plunge. Assays received from the single metre sampling at Nambi (see Table 1) have outlined high grade targets at the Main and E2 Lodes, the latter having been very lightly drilled in the past.






Gold 'tail' panned from E2 Lode, NBRC113 (1m @ 67g/t from 65 to 66m).
















Golden Terrace South

Drilling at GTS successfully intersected the interpreted southern extension of the main shoot at depth up to 170m south of the main GTS oxide zone, including 14m @ 3.50g/t (Inc. 4m @ 6.4g/t) and 12m @ 2.65g/t (Inc. 3m @ 5.90g/t). The southern shoot is open down plunge and is a priority drill target.

Drilling at depth down dip of the main oxide zone returned higher grade intercepts within broad intervals of mineralisation. Results including 1m @ 7.83g/t within 21m @ 1.70g/t remain open down dip.

Further drilling to extend the southern mineralised zone at GTS is planned in the current programme.

Regional Targets (Bindy & Kelly Trend)

Initial, wide spaced drilling at the newly discovered Bindy Prospect shows coherent, broad zones of mineralisation over 800m of strike. The geological setting is interpreted to be similar to the GTS deposit, being spatially related to sediment-volcanic contacts along the Great Western Fault. The Company is highly encouraged by these first pass, wide spaced drill results which suggest Bindy is a large mineralised system, and supports the Company's exploration philosophy that the Mertondale Shear Zone (MSZ) is highly prospective for further discoveries.

Drilling at KT prospect intersected broad zones of 0.1-1.0 g/t mineralisation within highly sheared felsic volcanic rocks. The mineralised zones remain open in all directions. Better single metre results over several hundred metres of strike included 9m @ 1.73g/t (*Inc.* 1m @ 5.92g/t), 10m @ 1.45g/t, and 11m @ 1.00g/t. At the Triple 2 prospect, an interval of 6m @ 1.14g/t was received.

Further follow up drilling targeting the higher grades zones at Bindy and KT is planned as part of the current drill programme.

NTM Chief Executive Officer Rodney Foster said:

"We are very pleased with the results from the RC drilling at Redcliffe, all five targets drilled have intersected +1.0g/t mineralisation, including some high grades at Nambi, GTS and our new Bindy discovery. The drilling demonstrates that high grade targets exist both at depth and along strike from both known deposits and new prospects. We look forward to the completion of the current RC drill programme which aims to extend and further define these high grade zones."
