Share Placement Notice Under ASX Listing Rule 3.10.5 and Section 708A of the Corporations Act and Appendix 3B

Following on from its announcement 21 November 2017 Inca Minerals Limited's (**Inca** or **Company**) is pleased to advise it has successfully completed the share placement (referred to in the aforementioned announcement) and issued 30,247,705 fully paid ordinary shares (**Placement**).

The Placement shares were issued at an issue price of 0.86 cents per share raising \$260,000 (net of raising costs). Funds are to be directed towards exploration at Inca's Cerro Rayas and Riqueza projects in Peru and/or for working capital.

Inca provides the following information pursuant to ASX Listing Rule 3.10.5 and Section 708(5)(e) of the Corporations Act.

Placement shares were issued without disclosure to Acuity Capital Investment Management ATF Acuity Capital Holdings under Part 6D.2 of the Corporations Act using Inca's 15% share placement capacity under ASX Listing Rule 7.1. As at the date of this notice Inca has complied with:
