### Schedule: Conditions to the ASIC extension

Under s250P(4) of the Corporations Act 2001 (Cth), ASIC imposes the following conditions:

- that the Company make appropriate provisions to ensure that the AGM is broadcast live online on a public website that is maintained by, or on behalf of, the Company (Live Streaming);
- (b) that the Company make appropriate provisions to ensure that shareholders are able to participate in the proceedings of the AGM, by either:
  - (i) submitting questions before the AGM that are then considered at the AGM; or
  - (ii) submitting questions to the Company or Company directors in real time through the Live Streaming process;
- (c) that the Company make appropriate provisions to ensure that the audio and video of the Live Streaming of the AGM is recorded and is made available to shareholders on the Company's website in a reasonable time after the completion of the AGM;
- (d) within two business days of receipt of the letter (confirming ASIC's grant of the extension), the Company must ensure that details of the extension of time for holding the AGM is disclosed on a public website that is maintained by, or on behalf of, the Company in a way that is readily accessible from the website; and
- (e) within two business days of receipt of the letter (confirming ASIC's grant of the extension), the Company must give written notice explaining the need for, and the effect of, this extension to ASX.
