

MEDIA RELEASE ASX: D13 **28 NOVEMBER 2017**

RESULTS OF THE ANNUAL GENERAL MEETING

PERTH, WA: DEPARTMENT 13 INTERNATIONAL LTD (ASX:D13) ("Department 13", "D13" or "the Company"), held the Annual General Meeting of Shareholders today 3:00 pm at Level 13 60 Castlereagh Street Sydney NSW 2000.

The resolutions were passed by way of a poll for Resolution 1 and 8 and on a show of hands for other resolutions. Resolution 4 being held under Listing Rule 7.1A was passed by the requisite majority as a special resolution.

The Company received 69 valid proxies representing 285,098,243 ordinary shares, being 54.4% of the Company's issued capital. The 69 valid proxies out of 1,688 total number of shareholders, being 4.1% participation rate, indicates a low turn out on shareholder proxy votes by number of shareholders.
