*During the AGM we will demonstrate the iVAN platform and our strategic alliance with US based company StackPath <https://www.stackpath.com/> bringing to what we believe a first to market complete white labeled Global OTT service from Content to Delivery and Applications. From our recent endeavors in Indonesia and*



*Brazil, TV2U will in 2018 be looking to set up a content acquisition division under the brand TARA (Television and Radio Anywhere) TARA will also be looking at new business opportunities based on freemium content and applications this business will be B2B, B2B2C and B2C where we will be able to monetize the data and analytics. As we progress with this venture I will keep you all posted.*

*As we enter 2018 with regular revenue, it will be time to look for expansion. We are now opening up a global distribution and sales network for our SaaS and PaaS (Software/Platform as a Solution) leveraging off our existing network of industry contacts which has already gained expressions of interest from projects based in Argentina and South Africa. As these opportunities mature you I will keep you updated.*

*We previously announced a new product OTT Multimedia and Connected Home 4GSet Top Box (“STB”) and our first pre-production boxes are now ready for market field trials. This box has been developed with our partners Xunison and Huawei <http://www.huawei.com/au/> who have given the box full telecommunications certification. This certification will vary depending on country destination and government regulations. The STB will not only support Z-Wave but also Bluetooth for Smart Home Automation, keeping in line with TV2U’s philosophy of being agnostic to any network or device.*

*As a result of its compatibility to a multitude of smart home devices, the deployment of the STB in the home is extremely cost effective unlike propriety solutions in the market that work on closed networks which are cost prohibitive.*

*Further to our company update announcement on 17 November 2017 in relation to our most advanced projects; PGASCOM Indonesia and SOL GO Brazil.*



*We are looking forward to the technical workshop to be held at our Kuala Lumpur office and NTT's datacenter from the 5th – 8th December 2017. Training will be provided to PGAS's technical team for running of services in Indonesia. TV2U's KL platform has been made ready for delivery of SMARTFREN forjiFlix branded OTT service as backup to the Indonesian operation. TV2U will be ready to launch as soon as the green light is given by SMARTFREN.*



*SOL GO is now available on both the google and apple store with the FTA (Free to Air) and Radio Stations. The service has been running live since the 15<sup>th</sup> November without a single issue, a great testament to Liaqat Fayyaz and his team in building a robust platform endorsing its readiness for global distribution. TV2U are aiming to complete the head end build for the premium live channels within the next few weeks in readiness for a pre-Christmas launch.*

*The support of our shareholders has helped to ensure TV2U moves into the New Year in a strong position and the Board thanks you.*
