First Cobalt Corp – Admission and Commencement of Official Quotation

Description

On 26 June 2017 Cobalt One Limited (“Cobalt One”) announced that it would seek to merge with First Cobalt Corp (the “Company”) pursuant to a scheme of arrangement. On 14 July 2017 Cobalt One announced it had entered into an implementation agreement with the Company, the purpose of which is to facilitate the merger to be implemented by a scheme of arrangement between Cobalt One and its shareholders. (“Scheme”).

Under the Scheme, the Company will be admitted to the official list of ASX and Scheme Shareholders (as defined in the Scheme documentation) will receive 0.145 fully paid common shares in the Company (“Common Shares”) for each fully paid ordinary share held in Cobalt One.

On 17 November 2017, Cobalt One announced that its shareholders had approved, amongst other things, the Scheme.

On 20 November 2017, the Federal Court approved the Scheme. The Court orders were lodged with ASIC on 21 November 2017.

The Company is admitted to the Official List of ASX Limited (“ASX”) on Wednesday 29 November 2017.

Official quotation of the Company’s ordinary shares (to be settled on ASX in the form of CHESS depository interests (“CDIs”)) is expected to commence on a deferred settlement basis at 1:00 pm AEDT (10:00 am WST) on 30 November 2017.
