

- Ozgrowth had a flat month with NTAs closing the month steady. The portfolio is up 14.6% (before fees and taxes) for the five months of the current financial year.
- The Ozgrowth cash position increased over the month to close at 12%, up from 7%.
- Key portfolio movers for the month were ATS (+12%), WSA (+10%), BPT (+7%) offset by declines from EMR (-11%) & MLD (-20%).


