## Additional MESMER™ Sales & Update

**PERTH, WA and COLUMBIA, MD USA** – DEPARTMENT 13 INTERNATIONAL LTD (ASX: D13) ("Department 13", "D13" or "the Company") a cutting-edge developer of counter drone technology, is pleased to provide this update on the ongoing sales of its MESMER™ units.

As part of its ongoing sales program, D13 can confirm that it is continuing to grow its sales with the recent sales of a further 2 MESMER<sup>TM</sup> units in December 2017 to clients in Australia and South East Asia, with shipping of the units sold expected to be completed by January 2018.

The units sold are the MESMER™ v1.0 and MESMER™ v1.5 units, and although the sale terms are commercially confidential, D13 has previously announced that the v1.5 unit sells for up to US\$400,000 per unit, including licensing fees.

Department 13 CEO, Jonathan Hunter, commented: "The use of MESMER™ as a solution to protect airspace over critical infrastructure is yet another key global market to D13. The Company is confident the ongoing sales and the successful implementation of MESMER™ will provide a reference of the product's capabilities to other authorities who are ultimately responsible for critical infrastructure. Importantly, D13 takes confidence that we are seeing are return customers. We continue to undertake demonstrations with customers globally, within the defense, critical infrastructure and commercial industries. The Company expects to be able to announce this calendar year a working capital facility that will enable the Company to begin building up its inventory in expectation of future sales."

In addition, further to the Company response to ASX on 29 November 2017, D13 advises that it has signed a non-binding terms sheet for a working capital facility with a suitably qualified lender, and anticipates confirming to ASX the execution of the binding facility agreement prior to the end of 2017. The working capital facility will be used to meet the Company's ongoing working capital requirements as it continues to build sales of its products. D13 will provide a further update, including all required details of the facility once final binding terms are signed.
