AVENIRA RECEIVES FINAL FUNDS UNDER ENTITLEMENT OFFER

Avenira Limited (**Avenira** or the **Company**) (ASX:AEV) is pleased to advise that, further to its announcement on 13 December 2017 of the completion of the Company's renounceable pro rata entitlement offer (**Entitlement Offer**), the Company has received the second tranche of funds from Underwriter, Agrifields DMCC, which completes payment for the subscription of 85,785,375 Shortfall Shares under the Entitlement Offer.

The Company has now received the full A\$15 million raised under the Entitlement Offer and subsequent Placement.

The funds raised under the Entitlement Offer and Placement will be used to further the Company's planned upgrade and expansion of its Baobab Phosphate Project, as well as providing general working capital.

Capitalised terms in this announcement have the same meaning as in the Offer Document for the Entitlement Offer dated 24 October 2017.
